A Resolution that supports the adoption of the proposed seal to become the official graphical image of the Undergraduate Student Government.

In the Senate of the Undergraduate Student Body here assembled,

1. **WHEREAS** the Undergraduate Student Government has been an important influence on the
2. campus of Bowling Green State University for 50 years and in that time has created a
3. successful and prominent organization, in which, in recent years, the student government has
4. found it difficult to advertise themselves to the student body, and

5. **WHEREAS** the adoption of the proposed seal is a small, but important, step towards an
6. increase in the recognition of the student government on this campus, and

7. **WHEREAS** Bowling Green State University has over 300 registered organizations on campus
8. and with that is the reality that students across campus can become confused with the many
9. acronyms that several large organizations use, and

10. **WHEREAS** the Undergraduate Student Government does to the governance model of the
11. United States Legislative System and thus should continue following the model with the
12. adoption of a seal, which the United States Code requires the authenticity and legitimacy of a
13. legislative body be invested in the seal of the state, territory, or possession of the United
14. States, and

15. **THEREFORE, LET IT BE RESOLVED** that the adopted seal will be used for promotion
16. efforts of the Undergraduate Student Government, will serve administrative functions both
17. internal and external, will be featured on any resolution, bill, official form, letterhead,
18. amendment, and any other administrative function determined by the Chief of Staff or
19. President of the Undergraduate Student Government, and

20. **THEREFORE, LET IT BE RESOLVED** that the proposed seal shall authenticate such
21. documents and make them official and legitimate, and

22.THEREFORE, LET IT BE FURTHER RESOLVED that responsibility of regulating the
23.use of the seal shall be vested in the Undergraduate Student Government Chief of Staff, and

24.THEREFORE, LET IT BE FURTHER RESOLVED that the President of the
25.Undergraduate Student Government can, at any time, overrule the approval or denial of use of
26.the adopted seal by the Chief of Staff and can, at any time, appoint another member of the
27.Undergraduate Student Government to relieve the Chief of Staff of the duties appointed to the
28.office in this resolution and will assume the Chief of Staff's duties when the position is
29.vacated, and

30.THEREFORE, LET IT FINALLY BE RESOLVED that the Undergraduate Student
31.Government supports the adoption of the proposed seal and that its implantation in the areas
32.stated above shall go into effect immediately and that the Undergraduate Student Government
33.recognizes the authority of the Chief of Staff as head of communications to regulate the use of
34.the seal and the authority of the President of the Undergraduate Student Government to
35.overrule that authority.
