A Resolution Formally Supporting the Creation of a web-page that shows parents and students information about student organizations that have been disciplined for hazing or other misconduct that threatens the well-being of students in the last five years.

### In the senate of the Undergraduate Student Body here assembled,

- 1. Whereas, the Undergraduate Student Government represents the undergraduate student voice
- 2. at Bowling Green State University; and
- 3. Whereas, Bowling Green State University and the Undergraduate Student Government
- 4. aim to ensure all student voices are represented within the Senate; and
- 5. Whereas, hazing and bullying is a major threat to the health and safety of both high school
- 6. and college students; and
- 7. Whereas, studies also show hazing is a broad and persistent issue within student
- 8. organizations and sports teams; and
- 9. Whereas, while hazing may take many forms, including menial labor, disparagement or
- 10. forced exercise, the addition of alcohol and drugs to these types of activities has caused
- 11. bodily injury to thousands of students and has been fatal in many instances; and
- 12. Whereas, we believe that every student has the right to learn and thrive in a safe and healthy
- 13. campus environment; and
- 14. Whereas, to eradicate hazing on college campuses, there must be increased transparency and
- 15. accountability inside all student organizations; and
- 16. Whereas, research shows hazing prevention is best accomplished through comprehensive
- 17. measures, including proactive education, transparency, and accountability;
- 19. Therefore, let it be resolved that parents and students should be provided with information
- 20. needed to make informed decisions about joining student organizations that have a history of
- 21. school-based sanctions for hazing or other misconduct that harm a student's well-being; and
- 22. Therefore let it be further resolved, that the Undergraduate Student Government of
- 23. Bowling Green State University requests that the Office of Campus Activities create and
- 24. maintain a web-page that shows parents and students information about student organizations
- 25. that have been disciplined for hazing or other misconduct that threatens the well-being of
- 26. students in the last five years.
