DEI Research and Mentoring Activities

- Our research program examines ethnic-racial and international samples.
 - Our currently funded research on exposure to violence is conducted in Flint, MI, and Jersey City, NJ. In Flint, our longitudinal sample is approximately 75-80% Black/African-American; in Jersey City, our longitudinal sample is 90% nonwhite, including 22% Black/African American, 24% Latino/a). Our goals are to understand how exposure to violence in high-crime urban areas predicts weapon use over time, what the mechanisms of this relation might be, and what protective factors there are, so that we can inform the design of prevention programs and public policy.
 - Our ongoing research in Israel and Palestine examines the effects of childhood exposure to ethnic-political violence (and family, neighborhood, and school violence) on the development of aggressive behavior, support for inter-ethnic violence, and post-traumatic stress symptoms. Our goals are to understand how exposure to ethnic-political violence predicts aggression and post-traumatic stress symptoms, what the mechanisms of this relation might be, and what protective factors there are, so that we can inform the design of intervention programs. The currently funded research by NIMH in which I am a co-

investigator focuses on the implementation and evaluation of an evidence-based family support program for parents and children in the West Bank and Gaza.

- At Bowling Green State University, I mentor graduate students in our APA-accredited Ph.D. program in clinical psychology. Four of my current Ph.D. students are from ethnic-racial minority groups; two of them are studying ethnic-racial identity and socialization processes, and one is studying sexual orientation-based bias victimization.
- In my position as Past-President of the International Society for Research on Aggression, as member of the organization's Council, and as Scientific Chair of our 2024 World Meeting, I mentor and collaborate with students and colleagues from around the world.
